Release of Liability: As a condition of the stable allowing me and/or my children to enter the property, be near horses, receive riding instruction, ride horses on the stable premises, and/or ride horses off the stable's premises, I waive the right to bring a lawsuit or any legal proceeding against David de Wispelaere, Relational Riding Academy, Michelle Binder-Zolezzi, Tom Zolezzi, NW Equestrian Specialties LLC and/or their respective officers, directors, partners, employees, agents, managers, trainers, instructors, heirs, representatives, assistants, insurers, assigns, and any others acting upon their behalf for any injury or death arising out of riding, training, driving, grooming, feeding, cleaning, providing general care for or riding as a passenger upon a horse.

I agree to assume full responsibility for any and all bodily injuries or damages which I and/or my child may sustain when on, near, or off the Stable's property as well as when riding horses on, near, or off the Stable's property. The term "damages" means, for example, medical expenses, expenses or losses incurred because of bodily injury or property damages, and/or personal property damages. I, for my heirs, administrators, personal representatives, relatives and assigns, release and discharge David de Wispelaere, Relational Riding Academy, Michelle Binder-Zolezzi, Tom Zolezzi, NW Equestrian Specialties LLC and/or their respective officers, directors, partners, employees, agents, managers, trainers, instructors, heirs, representatives, assistants, insurers, assigns, and any others acting upon their behalf of and from all claims, demands, actions, omissions, rights of action, or causes of action (both present and future), whether the claim be known or unknown, anticipated or unanticipated, resulting from or arising out of my or my guests' bodily injury or damage that may be sustained, or property which may occur as a result of my being on, near, or off the premises of the Stable, being near the horses, receiving riding instruction, riding on horses on the Stable's premises, and riding horses off of the Stable's premises.

Riding helmets are required for all riders at all times when on or off the Stable's premises.

Videos and Photography. All clinic participants and auditors agree to the following terms: "I agree to the following conditions: (1) Video and photographs of the clinic can be taken only for personal use and may not be further distributed, sold or published; (2) if the video or photographs taken at the clinic are distributed to the rider or owner of the participant horse, they must be labeled with the restriction that they may not be further distributed, sold or published; and (3) I will not photograph or take video of any participant on horseback I do not know."
